FINANCIAL SANCTIONS NOTICE

FSN-46-26

16/06/2026

Russia

1. The International Division of the Attorney General's Chambers advises that seventy (70) entries have been added in respect of the [Russia Sanctions Regime](#) and are now subject to sanctions, as follows:¹

- (a) Thirty-Two (32) entries, with respect to designated entities, are now subject to the following sanctions:
 - (i) Five (5) of the said entities are now subject to asset freeze, trust services sanctions, director disqualification sanction and prohibition on correspondent banking relationships and processing payments;
 - (ii) Twenty-Three (23) of the said entities are now subject to asset freeze, trust services sanctions and director disqualification sanction; and
 - (iii) Four (4) of the said entities are now subject to asset freeze, trust services sanctions, director disqualification sanction and transport sanctions;

- (b) Eleven (11) entries, with respect to designated individuals, are now subject to asset freeze, travel ban, trust services sanctions and director disqualification sanction; and
- (c) Twenty-Seven (27) entries, with respect to specified ships, are now subject to shipping and trade sanctions.
