### Russia

1. The International Division of the Attorney General's Chambers advises that one (1) entry has been varied, in respect of the [Russia Sanctions Regime](#)<sup>1</sup>. The said entry, which relates to an individual, remains subject to asset freeze, travel ban, trust services sanctions, director disqualification sanction and transport sanctions.
