### Russia

1. The International Division of the Attorney General's Chambers advises that one (1) entry has been amended in the [Russia regime](#)<sup>1</sup> and remains subject to an asset freeze and trust services sanctions, as follows:
  - John Michael ORMEROD (Group ID: 16863)
2. This follows an update to the UK Sanctions List. The consolidated list of asset freeze targets has been updated to reflect this change.
