FINANCIAL SANCTIONS NOTICE FSN-100-25

Russia

- 1. The International Division of the Attorney General's Chambers advises that seven (7) entries have been added to the Russia regime¹ and are now subject to an asset freeze and trust services sanctions.
- 2. This follows an update to the UK Sanctions List. The consolidated list of asset freeze targets has been updated to reflect these changes.
- 3. The full Notice was issued by the Office of Financial Sanctions Implementation of HM Treasury.
