### Cyber

1. The International Division of the Attorney General's Chambers advises that thirteen (13) individuals have been designated under the [Cyber Sanctions Regime](#)<sup>1</sup> and are subject to an asset freeze, travel ban, and director disqualification sanctions.
2. Additionally, one (1) entity has been designated under the same regime and is subject to an asset freeze and director disqualification sanctions.
3. This follows an update to the UK Sanctions List, as follows:
