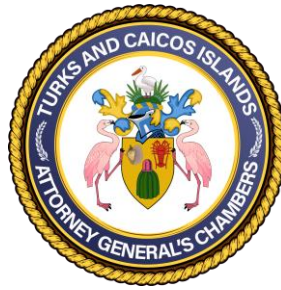
Russia

1. The International Division of the Attorney General's Chambers advises that ten (10) individuals have been designated under the [Russia Sanctions Regime](#)¹ and are subject to an asset freeze, travel ban, trust services sanctions, director disqualification sanctions and internet services sanctions.
2. This follows an update to the UK Sanctions List, as follows:
