### Russia

1. The International Division of the Attorney General's Chambers advises that three (3) entries have been amended in the [Russia Sanctions Regime](#)<sup>1</sup> and remain subject to an asset freeze and trust services sanctions, as follows:

- Yegor Yurievich KARASEV (Group ID: 16967)
- Anatoliy Moiseevich CHERNER (Group ID: 15963)
- THE MAIN DIRECTORATE OF DEEP-SEA RESEARCH OF THE MINISTRY OF DEFENCE OF THE RUSSIAN FEDERATION (Group ID: 16965)

2. This follows an update to the UK Sanctions List. The consolidated list of asset freeze targets has been updated to reflect these changes.
