FINANCIAL SANCTIONS NOTICE

Democratic Republic of Congo

1. The International Division of the Attorney General's Chambers advises that eight (8) entries have been added under the [Democratic Republic of Congo Sanctions Regime¹](#) and are now subject to sanctions as follows:

(a) Two (2) entries, with respect to designated entities, are now subject to asset freeze and;

(b) Six (6) entries, with respect to designated individuals, are now subject to asset freeze and travel ban.

2. This follows an update to the UK Sanctions List, as follows:
