FINANCIAL SANCTIONS NOTICE

Russia

1. The International Division of the Attorney General's Chambers advises that one (1) entry has been amended in the <u>Russia regime</u>¹ and remains subject to an asset freeze and trust services sanctions, as follows:

• LITASCO MIDDLE EAST DMCC (Group ID: 16976)

2. This follows an update to the UK Sanctions List. The consolidated list of asset freeze targets has been updated to reflect this change.

¹ The <u>Russia (Sanctions) (Overseas Territories)</u> Order 2020 (*Legal Notice 23 of 2021*) entered into force for the Islands on 31st December 2020 (the "Principal Order"). The Principal Order was amended pursuant to the Russia (Sanctions) (Overseas Territories) (Amendment) Order 2022, the Russia (Sanctions) (Overseas Territories) (Amendment) (No. 2) Order 2022, the Russia (Sanctions) (Overseas Territories) (Amendment) (No. 3) Order 2022, the Russia (Sanctions) (Overseas Territories) (Amendment) (No. 4) Order 2022, the Russia (Sanctions) (Overseas Territories) (Amendment) Order 2023, the Russia (Sanctions) (Overseas Territories) (Amendment) (No. 2) Order 2023 and the Russia (Sanctions) (Overseas Territories) (Amendment) Order 2024 and the Russia (Sanctions) (Overseas Territories) (Amendment) (No. 2) Order 2024, which are in effect for the Islands.
