FINANCIAL SANCTIONS NOTICE

FSN-63-26

06/08/2026

Russia

1. The International Division of the Attorney General's Chambers advises that nineteen (19) entries have been added, in respect of the [Russia Sanctions Regime](#),¹ and are now subject to sanctions, as follows:

- (a) One (1) entry, with regard to an individual, is now subject to asset freeze, travel ban, trust services sanctions and director disqualification sanction;
- (b) Two (2) entries, with regard to entities, are now subject to asset freeze, trust services sanctions, director disqualification sanction and transport sanctions;
- (c) Four (4) entries, with regard to entities, are now subject to asset freeze, trust services sanctions and director disqualification sanction;

- (d) Six (6) entries, with regard to entities, are now subject to asset freeze, trust services sanctions, director disqualification sanction and prohibition on correspondent banking relationships and processing payments; and
- (e) Six (6) entries, with regard to specified ships, are now subject to shipping and trade sanctions.
