Belarus

- The International Division of the Attorney General's Chambers advises that one (1) entry has been added to the <u>Belarus regime</u>¹ and is now subject to an asset freeze, as follows:
 - CJSC ALFA BANK BELARUS (Group ID: 16597)
- 2. This follows an update to the UK Sanctions List. The consolidated list of asset freeze targets has been updated to reflect this change.
