NOTICE

INTENTION TO REVOKE INSURANCE LICENCES 2 of 2019: PRODUCER OWNED REINSURANCE COMPANIES

Pursuant to section 34 of the Financial Services Commission Ordinance, the Commission may revoke the licence of an insurer if the insurer has ceased to carry on the financial services business for which it was licensed.

The Commission hereby gives notice of its intention to revoke the licences of the Companies listed below pursuant to its authority under section 34(1)(b) of the Financial Services Commission Ordinance since it is of the opinion that those listed companies have ceased to carry on insurance business.

Any person, who is likely to be affected by the revocation of the insurance licence or has a reason why the licence should **NOT** be revoked, is invited to submit written representation to the Commission, **no later than 4.00pm on Friday 24th May 2019**, as to why the licence should not be revoked.
